PROGRAM OVERVIEW

The Home Depot wants to give our nation's Historically Black Colleges and Universities (HBCUs) what they have given to so many. A strong foundation. Renewed purpose. Distinctive character. The grant portion of the RETOOL YOUR SCHOOL program provides schools with a chance to upgrade their campuses with support from The Home Depot. A total of nine (9) campus improvement grants will be disbursed. Schools will be divided into clusters based on student enrollment population. There will be one (1) Tier I Grant, one (1) Tier II Grant, and one (1) Campus Pride Grant per Cluster for schools that show the most initiative via web and social media activities promoting their proposed projects and garnering votes.

All government designated accredited HBCUs are invited to apply.

The Tier I and Tier II grants will be awarded based on consumer voting and project proposal scores by advisory board panel selection. The application with the highest score in each cluster will be awarded the Tier I campus improvement grant (\$50,000 level funding); one (1) subsequent application in the cluster will be awarded Tier II campus improvement grant (\$10,000 level funding). The winning schools for the Campus Pride Grant will be selected by a combination of the applicant's social media activity and Voting Score. The applicant with the highest votes and most social media activity in each cluster as determined by the sponsor during the Voting Period will be awarded with the Campus Pride Grant (\$25,000 level funding).



NEW ONLINE VOTING PROCESS


This year the Program will utilize a Cluster System. Under the Cluster System, each accredited HBCU is assigned to one of three groups ("Cluster") based on school enrollment data.

Clusters are as follows: Cluster 1: Enrollment 4,000+ Cluster 2: Enrollment 1,201 – 3,999 Cluster 3: Enrollment Up to 1,200 Clusters are subject to change at sponsor's discretion.

ELIGIBILITY

Who May Apply:

Respondents must meet the following criteria at the time of registration and through administration of the Grant:

- a. Have **accredited** HBCU status, as determined by the U.S. Department of Education.
- b. Have a tax identification number. Void where prohibited.
- c. 2014 winners ONLY must provide proof of completed project and submit current status photos of 2014 implementation by February 10, 2015 to participate.

Respondents must have access to the internet¹ and a valid email address to participate.

GRANT REQUIREMENTS

- RETOOL YOUR SCHOOL campus improvement grants are only open to institutions that are designated by the U.S. Department of Education as accredited HBCUs. See eligibility requirements.
- Grants must be sustainable and/or provide long term benefit to the campus. Submissions will be judged based on this criteria.
- All Proposals must be submitted in English. Each Proposal must be accompanied by up to six (6) images in JPEG Max 5MB in JPEG, Gif, PNG and TIFF format or one (1) video Max 50MB, MOV, MP4, M4V and WMV format. Proposals must be the original work of the Proposals must be the original work of the Respondent and may not have been previously published, released or distributed in any form, or may not have won any award outside of the RYS program. Addendums and/ or extensions to Respondents prior winning proposal are eligible for submission into the 2015 RYS program, as long as the work associated with Respondents prior winning proposal is complete (see (c) of the Eligibility section for proof of completion requirements). Respondent may provide one (1) proposal with three (3) completion benchmarks at \$10,000, \$25,000 and \$50,000, or complete three (3) separate Proposals for each award level.

HOW TO APPLY ELIGIBILITY

Step One: Review Program Overview and Grant Requirements

To maximize the impact of the campus improvement grant resources, The Home Depot RETOOL YOUR SCHOOL program only funds institutions that meet the eligibility requirements, which can be found in the Eligibility section. Please read and review the Program Overview and the Grant Requirements sections in their entirety before you begin the application process.

If you do not meet any of the established grant criteria as outlined in the Requirements section, please do not initiate the application process.

Step Two: Review Program Rules

Review The RETOOL YOUR SCHOOL Program rules. See Rules section.

Step Three: Review Frequently Asked Questions

Review the program's Frequently Asked Questions (FAQs) before beginning the application process. Contact The RETOOL YOUR SCHOOL Program staff only if you have any unanswered questions.

Step Four: Complete Part 1 of the RETOOL YOUR SCHOOL Grant Application - Registration and Letter of Intent (LOI)

To access the grant application visit <u>www.retoolyourschool.com</u> and click on "APPLICATION." All applicants must first confirm their intention to participate using the Letter of Intent (LOI) portion of the application. LOI must be completed and submitted online by February 10, 2015.

The purpose of the LOI is to provide confirmation to the RETOOL YOUR SCHOOL program staff that your institution plans to submit detailed proposals for Tier I, Tier II and Campus Pride campus improvement grants by February 26, 2015. Those institutions that do not register and submit an LOI statement by the deadline will not be allowed to apply for the campus improvement grants.

Applicants who have submitted the required Registration and LOI by the deadline will receive an email with information about how to access the full proposal submission form for the next round of the application process: Submitting Tier I, Tier II and Campus Pride Full Project Proposals.

If you do not receive an email confirming receipt of the Phase I and link to Phase II of application Grant Application Registration, Letter of Intent (LOI), please contact the RETOOL YOUR SCHOOL program staff via email at <u>staff@</u> retoolyourschoolprogram.com.

Information received after the deadline will be declined without review.

Step Five: Complete the RETOOLYOUR SCHOOL Part II Application Process: Submitting Tier I, Tier II and Campus Pride Full Project Proposals

Once your preliminary application (Phase I) is received, you will be instructed to submit a full project proposal online for each of the Tier I, Tier II and Campus Pride project grants. Those who

completed Part I by the requested deadline will receive a link to access the online submission form for the next round of the application process: Part II: Submitting Tier I, Tier II and Campus Pride Full Project Proposals.

Proposals must be submitted online by the full proposal deadline of February 26, 2015.

Only proposals completed and submitted by the deadline with full project descriptions and accompanied by up to six (6) images in JPEG Max 5MB in JPEG ,Gif, PNG and TIFF format or one (1) video Max 50MB, MOV, MP4,M4V and WMV format for each of the Tier I, Tier II and Campus Pride grants will be reviewed.

FREQUENTLY ASKED QUESTIONS

How many times may I apply for a grant?

The RETOOL YOUR SCHOOL program will consider only one proposal for each category (Tier I, Campus Pride and Tier II projects) from the same organization in a calendar year.

What are the requirements to apply for a campus improvement grant?

Institutions that wish to apply must register via the RETOOL YOUR SCHOOL program website (www.retoolyourschool.com) and click on

"APPLICATION." Applicants must meet eligibility and all application deadlines.

Can we promote our school's involvement with this program?

Yes, however, all such promotional and advertising materials must be approved in writing in advance by The Home Depot. No applicants or representatives can take part (or agree to take part) in any media interviews or events, or issue any press releases or other announcements regarding participation in the RETOOL YOUR SCHOOL program without the prior written consent of The Home Depot.

What is the focus of your HBCU campus improvement program?

The RETOOL YOUR SCHOOL program is a chance for Historically Black Colleges and Universities to upgrade their campuses with grants from The Home Depot in the areas of:

- Lawn Care/Landscaping
- Windows/Doors
- Energy Efficiency
- General Upgrades
- Lighting
- Paint
- Flooring
- General Construction

What type of organizations / institutions does the RETOOL YOUR SCHOOL program support?

Only Institutions of Higher Education (IHEs) designated by the Secretary of Education as accredited Historically Black Colleges and Universities (HBCUs) are eligible to submit an application to the RETOOL YOUR SCHOOL program.

Does The RETOOL YOUR SCHOOL Program accept unsolicited grant requests? No.

What is the deadline for submitting applications?

The RETOOL YOUR SCHOOL program makes grant decisions once a year. Grants for 2015 will be considered according to the following schedule: 2/10/2015 — Phase I and Letter of Intent (LOI) deadline

2/26/2015 — Phase II deadline for all three full project proposals: Tier I, Campus Pride and Tier II 5/8/2015 — Award notification

If selected as a winner, is there a deadline of when the campus improvement must be completed?

Yes, schools must complete project development paperwork and complete improvement projects on or before December 31,2015.

Grantees that do not adhere to this timeline could forfeit their ability to participate in the future.

When will the RETOOL YOUR SCHOOL grant awards be funded to the winning schools?

Winning schools will be notified via email on or around May 8, 2015. Schools will be required to complete a project development form along with a store quote provided by their local designated Home Depot store before the grant is disbursed. Once BOTH forms are completed received and approved, the grant is funded within 10-15 business days.

How do I know which cluster I am assigned to?

Sponsor will make Cluster Assignments using data provided on the LOI application.

1. <u>Cluster 1</u>, includes those Respondents with a student enrollment of 4,000 or more,

<u>Cluster 2</u>, includes those Respondents with a student enrollment between 1,251 and 3,999, and
 Cluster 3, includes those Respondents with a

student enrollment of 1.200 or less.

Sponsor reserves the right in its sole discretion to modify the Cluster.

Do I have to do 3 different proposals?

Respondent may provide one (1) proposal with three (3) completion benchmarks at \$10,000, \$25,000 and \$50,000, or complete three (3) separate Proposals for each award level.

Example 1 (single (1) Comprehensive Proposal) Improve Campus Plaza

- \$10,000 Benchmark landscaping, new flowers and shrubs
- \$25,000 Benchmark landscaping, new flowers, shrubs, brick stones, weather stain current gazebo
- \$50,000 Benchmark landscaping, new flowers, shrubs, brick stones, weather stain current gazebo, add seating to current gazebo, build additional gazebo with seating and solar lights to plaza

Example 2 (Three (3) Distinct Proposals)

- \$10,000 Update Campus Plaza
- \$25,000 Update stadium concession stand
- \$50,000 Go green dorms (LED Lights, recycling stations, energy efficient communal kitchen)

How are social media votes tallied?

Social media votes are defined as those votes that use the school's unique designated hashtag on Facebook,Twitter and/or Instagram.

Each time your school's unique hashtag is used on Facebook, Instagram or Twitter ONE (1) point will be earned per post. This includes retweets and reposts.

How will I know my "unique hashtag"?

2- Cluster 2, which includes those Respondents with a student enrollment between 1,251 and 3,999.

3- Cluster 3, which includes those Respondents with a student enrollment of 1,200 or less.

Sponsor will make Cluster Assignments using data provided on LOI application and National Center for Education Statistics. Sponsor reserves right to request enrollment verification.

Sponsor reserves the right in its sole discretion to modify the Cluster Assignment criteria listed above (via increase or decrease of the necessary

student enrollment figures of a Cluster or Clusters) based on the total number of Respondents that submit Proposals, towards fulfilling the goal of better equalizing the Grant selection chances amongst the Respondents.

Online voting will begin February 27, 2015, at 12:00 a.m. (midnight) EST and end April 20, 2015, at 11:59 p.m. EST ("Voting Period"). During the Voting Period, visitors to www.retoolyourschool. com (the "Site") will have an opportunity to vote for their favorite participating HBCUs. Site Votes are cumulative (i.e., they reflect all votes from the beginning of the Voting Period). Limit one vote per personal device (owned by the voter), per day during the Voting Period. Special unlimited voting periods may be made available at sole discretion of sponsor. Any Respondent or individual who, at the sole discretion of Sponsor, abuses the voting process in any way, including, without limitation, mass robotic voting, votes generated by a script or macro, use of automated devices or the use of multiple voter or email accounts or other fraudulent means, as determined by Sponsor, will be disgualified from the Program or from further voting and will have all their prior votes disqualified. Each Respondent's votes received via the Site and social media will be combined to determine that school's total online voting score (the "Online Voting Score"). Online Voting Score will be published on the Site based on Cluster Assignment. The Top Online Voting score per Cluster will be awarded the Campus Pride Award of \$25,000. NOTE: Respondents may not receive more than one Grant. Therefore, a Respondent that receives a Tier I or Tier II Grant is not eligible for the Campus Pride Award.

JUDGING CRITERIA

Tier I and Tier II Projects

All Proposals will be judged by a panel of advisors ("Judges") selected by Sponsor based on the following weighted criteria on a scale of 1 to 10, with "1" representing the lowest score and "10" the highest score ("Judge Score"):

- a. relevance Proposal to the **Requirements stated on page 10;**
- b. completeness of the Proposal;
- c. ability to execute the Project within the budget of \$50,000 or \$10,000, as applicable;
- d. ability of the Project to make lasting, positive transformations on the campus that are noticeable;

- f. Online Voting Score.

Respondents will receive one Judge Score for each Tier I and Tier II Project. The score will be based upon the Judges' evaluation of your efforts to meet the criteria outlined in sections (a) through (e) above.

Once final Online Voting Scores are determinable for each Cluster, all Respondents will be ranked from the highest to lowest number of votes ("Online Voting Rank"). Respondent's Online Voting Rank shall determine the number of additional points to be added to your Judge Score. Respondents may earn up to ten (10) additional points for their Judge Score. For example, Respondents from each Cluster with the top Online Voting Rank will



receive ten (10) additional points to their Judge Score. All other Respondents from each Cluster shall receive up to, but not more than nine (9) additional point(s) to their Judge Score.

If your Tier I or Tier II Project Proposal is selected, you will be notified on or around May 8, 2015, by email, as provided on your proposal.

CAMPUS PRIDE PROJECT

The winning schools will be determined by Sponsor and based on the following weighted criteria:

 Respondent's Online Voting Score which is combined votes made through retoolyourschool. com and Social Media Votes

Social Media Votes are defined as the use of the schools unique designated hashtag on Facebook, Twitter and/ or Instagram.

In order to be awarded a Grant, the campus facility/facilities that are the subject of the applicable Proposal must be in a minimum state

of condition that would allow the planned activities in the Proposal to proceed without any necessary remedial actions (e.g., no significant mold/mildew, structural damage, or dilapidation concerns that would deem the facility/facilities unsafe) in the sole opinion of Sponsor.
